The project is gaining recognition across the region and the first of these sessions was attended by Councillor Barry McCulloch who was impressed with the project and the impact upon older adults in North Lanarkshire. The second of our sessions was attended by Stuart McDonald MP for Cumbernauld, Kilsyth and Kirkintilloch East constituency. Mr McDonald was keen to see the impact of the project upon older people's confidence to become digitally confident.

#### Lanarkshire Links AGM

Representatives attended the AGM and workshops of Lanarkshire Links recently in the Alona Hotel.

### Clinical Psychologists for Older People

The Forum were asked to give a presentation on the work which we undertake, along with the benefits of the Chatterbox project, to the regular meeting of Clinical Psychologists who are exploring new ways to engage with older people. This received a positive response from all who attended and opportunities exist for further exploration of this topic.

#### ADULT DISABILITY LIVING ALLOWANCE



Following pilot schemes, the Adult Disability Payment was made available in all council areas from 29th August. It replaces the UK Government's Personal Independence Payment. The benefit provides financial support

to people aged between 16 and state pension age, who are disabled, have a long-term health condition or have a terminal illness.

People already receiving the UK Government's Personal Independence Payment and Disability Living Allowance **do not** need to make an application for Adult Disability Payment. These existing awards will transfer automatically from the DWP to Social Security Scotland. Cases will transfer in stages and this process is expected to be completed by the end of 2025.

#### TACKLING BOGUS CRIME

A new "No Cold Calling" zone has been introduced in the Larch Grove area of Cumbernauld. The zone – the first of its kind in North Lanarkshire – has been launched as a joint initiative between Police Scotland and North Lanarkshire Council Trading Standards to reduce incidence of crimes resulting from bogus callers, rogue traders and distraction thefts by raising awareness in the community, educating householders and in particular elderly and vulnerable people to improve their home security.

New signage has been put in place - residents have been provided with no cold calling stickers which are displayed on their doors and windows. Regular patrols will be undertaken by local community officers and engagement with residents and the sheltered housing warden. The new zone is being treated as a pilot and the intention is to expand more widely across Cumbernauld, Kilsyth and the Northern Corridor if successful.

## NORTH LANARKSHIRE CARERS TOGETHER

North Lanarkshire Carers Together (NLCT) have launched a new Carer Information resource aimed at informing carers and health and social care professionals on the services offered by their organisation. The pack is available to download via the NLCT website and can used by carers who wish to direct to their services.

A range of information is available containing essential information on who they are as an organisation, as well as crucial details on specific supports available, the pack outlines areas including:

As always, there are currently a number of scams going around.

**Beware of: IMPERSONATION** - Fraudulent messages offering tax rebates or government grants/funding related to the cost of living crisis. Do not respond to these as they are trying to obtain your personal details.

**COVID** - Texts claiming to be from NHS saying that you have been in close contact with someone who has tested positive for Omicron, asking you to order a free test. These are designed to gather your personal details only.

**UTILITY GRANT**—The latest trick involves sending a malicious text message link that asks you to sign up for the government's energy grant. If you get one of these texts, don't click on the link. Your grant will be applied to your energy account automatically.
